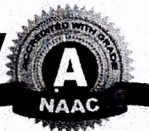

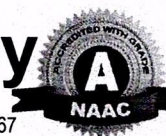

2. **Agenda Item No. 2:** Action taken report on the minutes of Board of Studies held on 04th June 2019.

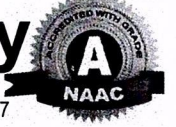

The meeting ended with the vote of thanks.

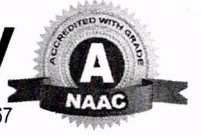


