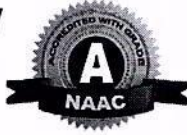

Discussion and Resolution:

The minutes of the meeting of Board of Studies held on 20/09/2019 were approved unanimously. This was resolved that action taken report will be submitted by the concerned/ respective faculty members within time.

2. Agenda Item No. 2:

To Introduce Moocs/Swayam Courses and acceptance of their credits in B.A.LL.B./LL.M. Program.

Discussion and Resolution:

This was resolved that B.A.LL.B. Program is regulated by BCI which is a statutory body for the program and without having any direction from Bar Council of India Moocs/Swayam online Courses cannot be introduced as alternative courses in B.A.LL.B. Program. For the LL.M. Program it was placed that research methodology course is available on Moocs/Swayam portal. This was brought before all that UGC and MHRD are insisting upon the regular and compulsory classes for research methodology course at M.Phil & Ph.D. level. Therefore acceptance of credit for this course on the basis of Moocs/Swayam online course credit is not advisable. Out of 13 members, 12 members were of the opinion that this course must be compulsory as class room course whereas one member (Dr. Manoj Kumar Tripathi) objected and had a dissent opinion. Board of Studies concluded that since research methodology is a compulsory course at P.G. Level in different streams hence University may have a uniform policy for all the programs on the issue.

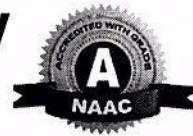
