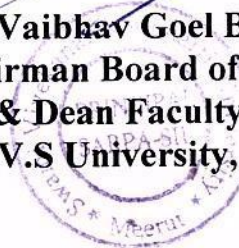

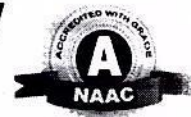

3. Agenda Item No.3: Discussion on the analysis of attainment as per the course objectives and course outcome.

1. Analysis of the attainment as per the course objectives and course outcome of the programme was brought before Board of Studies and the Discussion upon analysis of attainment was made on the basis of Bloom Taxonomy.
2. After analysis it was observed that the attainment is high except the subjects 1. History of courts and Legislation (B.A.LL.B) IInd semester and 2. Law of Industrial and Intellectual Property (LL.M) IVth semester, where the attainment was found low. Both the subject teachers were suggested to improve their teaching methodology according to the standard of paper keeping in mind the course and program out come. This was brought before the committee that History of Courts and Legislature is slightly dull and Law of Industrial and Intellectual Property is technical one, which may be the cause of the poor performance. The Committee suggested them to improve teaching pedagogy and further suggested to create interest if the subject is dull and call external experts if the subject is technical one.
3. This was observed that the level of attainment is by in large high which signifies change in the level otherwise improvement of the educational standard will not be possible. Earlier for internal assessment the line of level settling was 50% marks and 55% in external assessment, this is required to be upgraded or there is requirement of modifications in the Course and program out come. After discussion this was said that time should be given to all the teachers to work on this and to think. Hence it was decided to invite suggestions from all the faculty members to change the criteria of attainment level or otherwise.. Concerned faculty members were directed to submit their suggestion within a week so that the issue can be taken up in the next Board of Studies meeting before the beginning of the new session.
